If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. In-network primary care, specialist, urgent care, virtual care, outpatient mental health and chemical dependency, outpatient rehabilitation and habilitation, outpatient diagnostic x-rays and labs, acupuncture, massage therapy, spinal manipulation, children's dental check-up services, and most preventive care as well as in and out-of-network value, select, preferred and non-preferred prescription medications, children's routine eye exams and glasses, and hearing aid services are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount.
