What is the overall <u>deductible</u> ?	\$0 at Indian Health Care <u>Provider</u> (IHCP) or with IHCP <u>referral</u> at non-IHCP. For non-IHCP <u>network providers</u> \$2,200 individual / \$4,400 family. For <u>out-of-network providers</u> \$4,400 individual / \$8,800 family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Services received at an IHCP or with an IHCP referral are covered at no charge. In-network preventive care, primary care, <u>specialist</u> , <u>urgent care</u> , virtual visits, outpatient mental health and chemical dependency, outpatient rehabilitation and habilitation, children vision services and adult eye exams, as well as most in and out of <u>network</u> prescription medications are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive</u> <u>services</u> without <u>cost sharing</u> and before you meet your <u>deductible</u> . For <u>out-of-network providers</u> \$76,000 individual / \$152,000 family.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. Does this plan provide Minimum Essential Coverage? Yes.
