Out-of-network providers are not covered without IHCP referral.</p>	<p>Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. Services received at an IHCP or with an IHCP referral are covered at no charge. In-network preventive care, primary care, specialist, urgent care, virtual visits, office visits for outpatient mental health and substance use disorder, outpatient rehabilitation services and habilitation services, children’s eye care, as well as in and out of network value and select medications are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven’t yet met the deductible amount.
